4. Update from Participants Canfor - Andrew Tyrrell

- Mill operations: Great markets, supply/demand imbalance, shipping challenges
- Sawmill has had no downtime during pandemic and running very well, staffing changes, capital upgrades planned for 2021, pellet plant and Taylor pulp continue to run
- Woodlands: summer 2020 was challenging (very wet), low log inventory going into fall, looking better now, pretty much on target for end of winter inventory no major safety incidents; infrastructure investment planned on some roads (resurfacing), Kobes Creek bridge replacement, installation of remote scale/log storage yard
- Woods misc.: spruce beetle monitoring, Rezatec remote sensing imagery, Core-Periphery layout and near-term plans further away from town; increased use of drones

Comment: Lyle stated he has been a longtime critic of PAG and whether it resulted in better forest management, but now, from HRFN perspective, Canfor has exceeded the PAG expectations in wildlife retentions, protecting mineral licks, etc.; Canfor is also currently employing Six Nation Ventures, and Lyle is seeing the benefits. He also is seeing Canfor changing plans to go after spruce beetle areas as per HRFN request. Question: has there been a reduction in aerial spraying this year? Carmen: every year we end up reducing/modifying the plan which creates a reduction. Budd remembers an update showing a reduction over 5year span (about 2 years ago was shown in a meeting); he is wondering if spraying has continued to reduce and at what rate? ACTION: Stacy Gibbons to email Budd an update with the reduction amounts.

BCTS, Stephanie Smith

- Hiring 4 new staff
- 2020-21 sales 410945
- 2020-21 harvest volume 283104
- 2020-21 silviculture program
 - o Trees planted 2315925
 - o Manual brushed 278.1ha
 - Chemical treatment 70ha

<u>Comment</u>: Lyle, BCTS has also reduced chemical treatments, a little slower than Canfor who lowered faster, keep up the good work in reducing spray.

Cameron River Logistics

No update

Louisiana Pacific, Derry Sorgen

- LP is reopening the Fort St. John plant, hiring 180 people in all positions; in woodlands wanting to hire 10-11 people to start with
- Brought in decked wood (about 95% is now in) which had started prior to announcement of opening
- Some LP plants are converting to siding mills which will offset the impact of PVOSB's production on the market supply; lots of work around production and costs to maintain viability and longevity
- One forest license expired in December, meeting with the Ministry weekly regarding forest license and permitting; working closely with Canfor in terms of land base and contractors, road use, etc. – Canfor not managing fibre, but both companies are working closely together. LP will continue participating in PAG.
- In regards to BCTS, LP will be maximizing the volume they can get from timber sales, trying to get a bunch of purchase wood, SFI certification, spring decking program to start hauling in the summer a lot is happening!
- Staffing the office, consultants, and log yard (haven't finalized the log yard and should discuss with Lyle in the coming weeks)

Comment: Lyle - congratulations on the restart, Six Nations Ventures are not pleased with how the relationship ended, requested a yes/no/maybe in the last few months on whether they would be needed, but no response was given (not good when had equipment sitting), but thankfully Canfor employed. Six Nation Ventures did not like how it happened, doubt the same type of consideration environmentally will be taken that Canfor/BCTS has shown. Derry – we have had a conversation regarding this previously, and in terms of the log yard piece commitments could not be made while down (even a yes/no/maybe)

Question: when will the first reports be on these changes? Tony: this fiscal year (2021 year)

6. Access Management planning - Andrew Tyrrell

- Deactivation, Access Management, Prescriptions and Communication reviewed.
- Participants build a lot of road to support fibre extraction

Deactivation

- Deactivate to minimize erosion, sediment delivery; protect investment; recovering/redeploying structures; limiting liability
- Deactivation techniques: installation of skewed water bars, cross-ditches, ditch blocks, remove culverts, log fills, bridges, cattle guards; application of reclamation seed mix;

Manage access

- Coordination of activities on shared land base; commitments made to address FN concerns; commitments made in strategic plans, and with 3rd parties
- Produce and share a deactivation plan/ access management prescriptions shared before harvesting for site specific basis

Question: Ray Ensz: has had conversations with the Participants regarding access management, on field trips has spoken to access; Lyle wanted to see this happening and it is now, each time a block is cut debris is placed on roads leaving it impossible to trap, cut lines are not left open, how did that get put into prescription without rest of PAG knowing it would happen? No one spoke to Ray (Trappers' representative) about leaving cut lines open; once a block goes across it becomes un-accessible. Andrew does know of examples where it has worked, it has to come down to trapper/Canfor planner/BCTS getting involved and creating a discussion to highlight specific concerns and have a chance to leave stuff open. Andrew is happy to meet with Ray or other trappers regarding their concerns and addressing site-specific issues. Knowing what roads trappers are using for access is helpful. Ray understands the need to deactivate access and trying to preserve wildlife, but trappers are trying to trap predators.

<u>Comment:</u> Lyle: roads that his client is concerned with are new access roads from a main road in, those are the ones his client does not want to have left accessible; in his experience, if you approach Canfor regarding existing traplines or trails should be kept open to continue using.

7. Guest presentation – Rod and Gun Club – <u>Prescribed Burns for Wildlife</u> Habitat Presentation – Alicia Woods, MSc. RPBio

Prescribed fire for wildlife is used to create and manage important habitats for wildlife. They have been in use for a long time and are a natural mechanism in controlled and targeted method. Prescribed burns improve habitat by increasing forage amount and quality and are primarily used to improve winter range.

It is a complicated process; if fire goes as planned (intensity, location, fuel consumption) the results are plentiful: vegetation growth with greater biomass, greater nutritional quality; wildlife is healthier, greater populations, proper range and decreased predation.

Two projects with Rod & Gun Club:

<u>Project 1 Tuchodi Burn Project:</u> lack of habitat management in the area for >30years, low-elevation elk, deer and moose habitat is disappearing due to aspen encroachment, decreasing moose/elk populations, increased competition between elk and caribou /stone sheep in high elevations habitats

<u>2017 Tuchodi Burn Project:</u> 11 sites burned for Stone's sheep and mountain goat, 1200ha of sheep habitat restored

<u>Tuchodi 2021 Burn:</u> Additional 13 sites proposed for spring 2021; focus on lowelevation sites with the objective of reducing the aspen encroachment, improve forage quantity, increase line-of-sight, maintain spatial separation from caribou and sheep

Effectiveness monitoring is important part of projects; requirement by FLNRORD & HCTF

Project 2: Sharp-tailed Grouse Habitat Restoration

Peace Breaks - Golata Creek - Prescribed burning

Cache Creek - Manual brushing

May be trying to go through tenure holders than the government process to reach a faster decision.

Questions:

Mark: some of the lower/medium slopes for ungulate burns showed a lot of dead aspen/birch/etc. stems – do they fall and rot, or do they need to be burnt again? Alicia; very site specific, some cases yes, some cases may need a second treatment when thicks start falling down, if they haven't been treated in a long time.

Darrell: if there was interest in getting some burns off the valley bottoms that have over story timber, Canfor would be interested in discussing.

Kaleb Bellamy: the rod and gun club would be interested in partnering with Canfor on burns, and will reach out to Andrew Tyrrell.
